FIRST THURSDAY LUNCHEON SPEAKER

JIM LUSSIER is founder and principle consultant with *The Lussier Center/TLC* which is focused on the quest for personal and organizational performance excellence through the development of optimum governance and leadership that creates a preferred future for their organizations.

Mr. Lussier has focused his professional life on high performance organizations for over 36 years. He has served at executive level and as a CEO in healthcare organizations and provided counsel and training to hospitals and health systems in Netherlands, Africa, Japan, Canada and the United States. He has consulted with the University of Pittsburgh, The American Hospital Association and is currently serving as the Research & Development Chair for the Facilities Guidelines Institute in conjunction with the American Institute of Architecture. He also serves as a consultant with Transformation Systems International/The Performance Center.

Mr. Lussier advocates for the transformation of healthcare and speaks internationally on organizational and personal leadership, transformational healing healthcare design and the development of integrated health systems designed to improve community health status. He presents Board of Director governance effectiveness & leadership development programs and counsel across the country to educational, healthcare and community boards and staff. Mr. Lussier is a guest lecturer for Concordia, Oregon State University and other organizations. He counsels numerous business organizations in the development of performance excellence utilizing the Baldrige National Quality Award program criteria and was a Baldrige program examiner in 2004.

He served on the Board of Directors of Cascade Healthcare Community (CHC) where he was President/CEO for fifteen years until July 1, 2004 and as President Emeritus until 2006. CHC operates St. Charles Medical Center and St. Charles Medical Center-Redmond, Oregon. Jim has been employed in health care for over 36 years in a variety of capacities. Under his leadership, St. Charles ranked as one of the nation's "Top 100" hospitals in recent years, is noted for its excellence, patient-focus and healing health care, as one of the "Top 40" places to work in Oregon and was a recipient of the "Oregon Quality Award." He remains on the St. Charles Foundation Board of Directors.

Mr. Lussier is an active member of seven boards and commissions. He has previously served as both member and President of the Oregon State Board of Higher Education, overseeing the seven public Universities in Oregon and the Oregon Health Policy Commission.

-Some historical background as to how the adversarial positions of the health care stakeholders in Central Oregon have developed.

-Whether the divisions between the physicians who have joined the Physicians Hospital Alignment for Central Oregon and the physicians who have united to serve as a counterbalance to the hospital system are good for patient care in Central Oregon.

Do these divisions affect a patient's ability to choose a provider among the stakeholders?

-Does this rivalry among providers lead to duplication of diagnostic tools (X-RAYS, CAT SCANS, BONE DENSITY SCANS, LABS, SURGERY CENTERS, ETC.) which could result in higher costs to the patient?

-Historically, what attempts have been made to bring all the stakeholders together to try to solve what the public could perceive as a problem?
